 for public comment until May 4th
- The ceremonial signing of HB295 took place yesterday

Simulation

- Pediatric mannequin (Aria) was delivered last week
- Two more mannequins are on order (maternal fetal simulators)
- Currently doing interviews for Standardized Patients
- Using Vimedix for OB/GYN purposes this week
- Will be ordering four task trainers; Parts should be here first couple of weeks of May

Advancement

- Plans to name the screening of the elementary school children "Kaufusi's Keikis"
- Tomorrow there will be a meeting with other interprofessional educators around the state; Discussions about partnering will take place.

- Goal is to have the first screening towards the end of the first semester next year, and additional elementary schools during the second semester. End goal is to have every elementary school in Provo (K-5) involved within 3-4 years. City council members have been met with individually; Enthusiastic and supportive.

Graduate Medical Education

- There is interest from Timpanogos Regional about starting a pediatric residency program
- Have finished the non-electronic version of ACGME's ONMM application; Dr. Halma is reviewing it. Once there is a sponsoring institution, can proceed with electronic portion.
- Speakers' bureau of subject matter experts is being created

Student Affairs

- 109 paid acceptance fee's (first <u>and</u> second fee), 135 offers currently pending, 77 paid matriculation fees, 50/50 male/female, 16% URM, 506 average MCAT, 3.4 average science GPA, 3.49 average overall GPA, 103 students are registered for Accepted Student Day.
- 20-25 students attended the BYU open house, ambassadors attended. UVU open house will be tomorrow.
- Please attend Ramadan event; Students will be conducting a panel.
- Diversity Art Contest submissions are due April 29th
- Students are utilizing the food pantry; Meeting today with other COM schools, food insecurity is a common theme across the country. Non-perishable and hygiene items are appreciated. May reach out to Clark Bishop to take part in additional welfare system.
- Registrar position is posted
- \$70,000 scholarship is currently available; Students may apply until Monday
- Working with other COMs on tuition comparisons

Research

- First student author peer reviewed paper was accepted into the journal of Future Medicinal Chemistry
- Machine learning engineer has created algorithms in software, and a visual representation of students who closely represent the demographics of students Noorda may be looking for. Intended to reduce workload as well as entertain more primary applicants that may have initially been eliminated due to an application shortcoming. Allows for sifting through applications quicker than the current method.
- Last week, discussed with Roseman the advancement of their South Jordan campus to a BSL2 facility. Also, came to an agreement in kind that there will be an engagement of a grant matching program for faculty.
- Similar/successful discussions with BYU's Technology Transfer Office regarding generating of seed funds and sharing of a portfolio and intellectual property.
- We now have our first position on a BYU PhD committee
- Noorda research symposium is taking place in May; Abstract deadline is April 19th
- Beginning next month, a research podcast will be broadcast twice/month (items such as upcoming events in research and showcases of successes will be spoken on)
- Along with Dr. Kriak, have written a research misconduct allegation policy and handbook (mandatory compliance document needed to move forward with federal funding)

- Meeting tomorrow with other interprofessional educators around the state; Discussions about partnering will take place. Goal is to have the first screening towards the end of the first semester next year.
